### EXPUNGEMENT ELIGIBILITY ASSESSMENT

### NEW YORK -

Criminal Procedure Law 160.50 permits the "sealing" of cases where charges were dismissed, vacated, set-aside, not filed, or otherwise terminated. Otherwise, New York does not allow expungements, or "sealings," of cases where a conviction was entered, except for some older controlled substance, marijuana, and loitering offenses. Sealing a record under 160.50 will prevent the public from having access or seeing the records, including fingerprint cards, photographs, court entries, and other information related to the case. The record may still be made available to some entities, such as courts and law enforcement.

Effective 2009, New York Criminal Procedure § 160.58, a petitioner convicted of most felony drug, marijuana, or Willard non-drug eligible crimes may request to have their records for those crimes sealed if they successfully complete DIVERSION, DTAP, or a similar substance abuse treatment program recognized by the court. The sealing will also extend to up to three of the petitioners misdemeanor drug convictions.

### UTAH -

To expunge records of crimes with a conviction, the petitioner must first pay all fines, fees, restitution and interest. Unless a person has been pardoned for the offense, records of the following crimes cannot be expunged:

- a capital felony, first degree felony or violent felony
- automobile homicide;
- felony driving under the influence; or
- a registerable sex offense;

A person cannot expunge records of any conviction if:

- the petitioner provides false or misleading information on the application for the certificate of eligibility; (It is also a criminal offense to provide false or misleading information on the application.)
- there is a criminal case pending;
- the petitioner has been convicted in separate criminal episodes of:
  - two or more felonies;
  - three or more crimes of which two are class A misdemeanors;
  - four or more crimes of which three are class B misdemeanors; or
  - five or more crimes of any degree other than infractions and the traffic offenses.
